Introduction

Thank you for your interest in the Burlington Children's Space. The Burlington Children's Space offers care for children between the ages of 6 weeks to those leaving for kindergarten. We are currently open M-F 8:00am-4:00pm. A limited number of part time slots are available within the program. We offer a sliding fee scale for tuition and accept State subsidy payments for child care as well. Spaces are reserved for infant and toddler families who qualify for Early Head Start services.

If you would like to be considered for a spot at BCS, please complete this form and return it along with the wait list fee of \$25.00. There is an option to waive the fee if it is a barrier for your family. New children usually enter the program at the end of August/beginning of September, but the enrollment process begins in January, with siblings and staff babies given priority. There is a one-week transition period of half days (noon) for children starting in the program. After current families have been enrolled, we will contact wait list members about any openings we have.

Act 166 funds will lower the tuition of Pre-K students. However, since the sliding scale is calculated on a family's ability to afford ECE, it will not *further* reduce BCS sliding scale rates that are already below the cost of Pre-K less Act 166.
